NARRATIVE 1	

Upon arrival at GDL [MMGL Airport], we were cleared to taxi to the ramp via Taxiway A. Approaching an intersecting runway, we observed that we would be taxiing on a new Taxiway A and that the old Taxiway A was under heavy construction. This was not listed on the NOTAMS or the company page. FD Pro [shows] the aircraft on the new and uncharted Taxiway A in relation to the closed and under construction Taxiway A.

Cause: NOTAMS and more importantly, the GDL taxi charts are not current.

Suggestions: Inform company pilots of discrepancy and update the taxi charts for GDL.

SYNOPSIS

First Officer reported Taxiway A at MMGL airport was undergoing heavy construction and that the "new" Taxiway A was not listed in the NOTAMs or displayed properly on their taxi diagram charts/display.
