It was dark when we taxied for takeoff to Runway 06 via [Taxiway] A. At the end of the long stretch of A there are either no edge lights at the southwest end of that taxiway or they were inoperative. There is a danger of a taxiway excursion from A if a Captain was not paying close attention to remaining on A as he makes the first of the two left turns to line up on Runway 06. There were no errors made on my taxi out that night. I am providing this as a general safety concern for HAV (MUHA) operations. Provide info to pilot's company information or airport briefing info regarding poor/non-existent lighting at the end of Taxiway A before entering Runway 06.

SYNOPSIS

Air carrier Captain reported the lack of taxiway lighting at the end of Taxiway A at MUHA Airport may lead to taxiway excursion.
