Concourse A South has a 90-degree pushback requirement. There is also construction on [Taxiway] AS. While waiting for our gate to open, we saw 2 aircraft directly adjacent to the construction areas startup and single engine taxi out. We observed lots of dust and debris, workers turning around so they wouldn't get blasted in the face, plastic coverings getting blown around, and workers trying to hold things down. This did not appear to be safe and I would not feel comfortable being on the ground in such close proximity to an aircraft taxiing out.

## **SYNOPSIS**

Air carrier First Officer reported they observed jet blast blowing dust and debris onto construction workers and their equipment across from Concourse A on Taxiway AS at DEN.
