NARRATIVE 1	

My supervisor, coworkers, and I were collecting equipment and returning it to the hardstand (the location where we park said equipment) at Terminal 5. I was recovering a cargo loader and turning in to park, where there are no indicated lines of parking, when I hit the left side of an already parked cargo loader with the side of the one I was operating. The cargo loader I was driving was undamaged but the parked loader did have some damage to the left flap. The parked cargo loader was in an area that is not adequately lit and outside of the lit portion of the hard stand.

CALLBACK 1

Reporter indicated location is ORD, and Terminal 5 is used by multiple air carriers.

SYNOPSIS

ORD ramp worker reported returning a cargo loader to the terminal hardstand resulted in a collision with another loader parked in an inadequately lit area.
